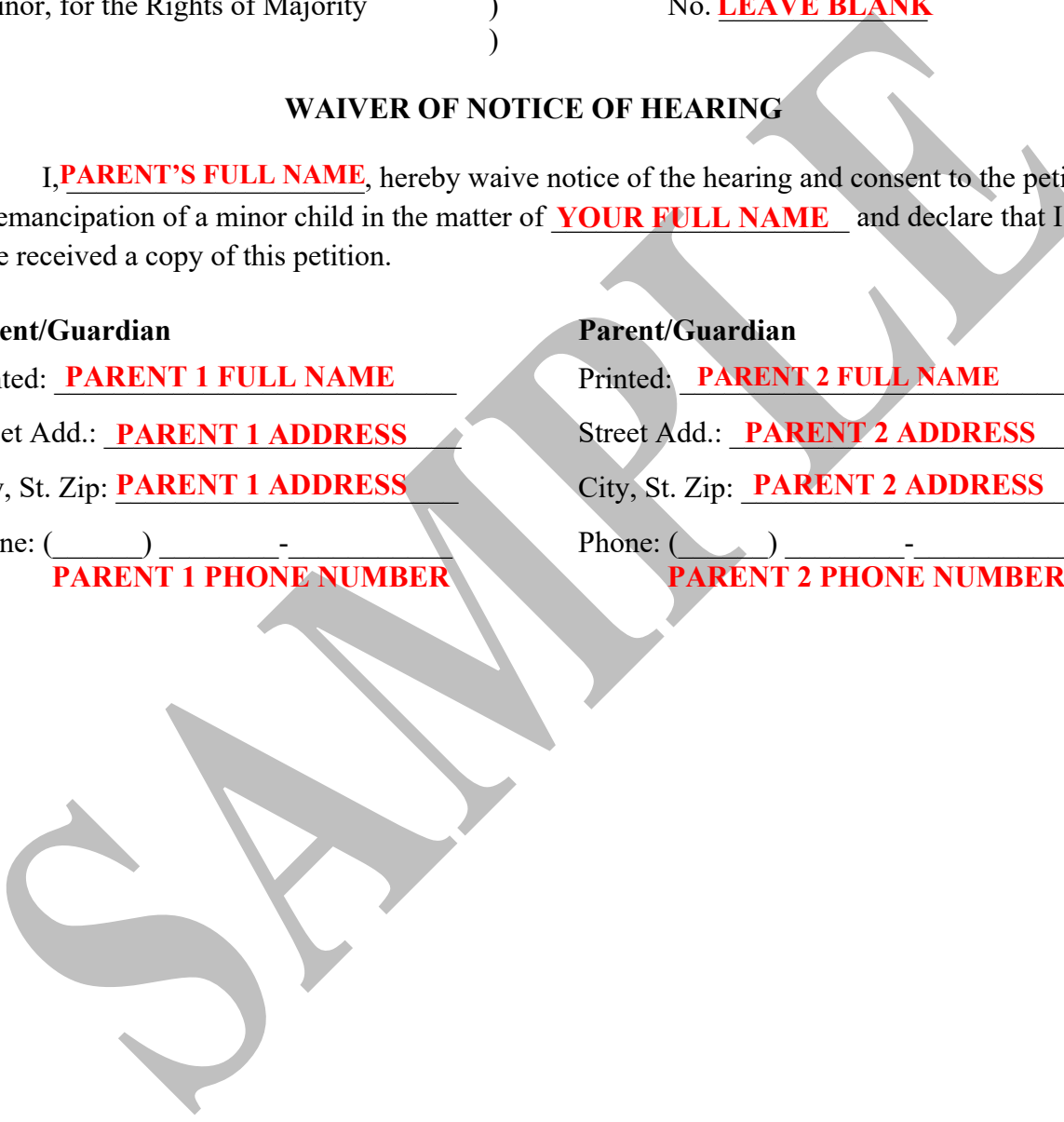

DECREE CONFERRING RIGHTS OF MAJORITY

The Court proceeded to examine the said minor, YOUR FULL NAME, witnesses were sworn and examined; and the Court, having examined the file and records herein, finds: YOUR
